
To ensure your privacy and security, the following information is **required**:

- Primary Filer's Last Name
- Tax Year
- Adjusted Gross Income (AGI) or Total Household Resources (THR)
- Filing Status

Guest Services	Account Services	Inquiries

Using "Guest Services", you are required to answer verification questions <b>each time</b> you access a <b>different option</b> . Using "Inquiries", you may ask an Account Specific question or request a copy of a letter/tax return/check or ask General Topic questions.
